## Sexting

Sexting, v: (a combination of sex and texting) is the act of sending sexually explicit messages or photos electronically, primarily between cell phones.

### Sexting Stats

- •57% reported that they had been asked to send a sext
- •11% of teens admit they've sent pictures to strangers
- •80% of teens who have sexted are under the age of 18


# In re Juvenile John Does (Fairfax Co. Va. 2013)

- Girls Snapchatted video to boy
- He forwarded screenshots to friends
- Three boys arrested at school
- Each charged with 12 counts of distribution of child pornography
- Found guilty, registered sex offenders, sentences upheld

#### Nebraska Law

- ■Neb. Rev. Stat. 28-813 et seq.
- Makes sexting (images) a class IV felony for offenders under 19
- Class IIIA felony for 19 and up
- Both punishable by:
  - Up to 5 years in prison and/or
  - \$10,000 fine
  - Require sex offender registration

# Taylor v. Francko (Hawaii 2016)

- William Francko proposed to Leona Taylor
- She refused
- •He posted nude photos of her online, along with her contact information
- Sued for public disclosure of private facts, defamation of character, and infliction of emotional distress.
- Court entered judgment against Francko and awarded Taylor \$425,000 in damages

#### Criminal Consequences

- NEB. REV. STAT. 28-311.01:
- Terroristic Threats: "threatens to commit any crime of violence ..."
  - With the intent to terrorize another
  - In reckless disregard of the risk of causing such terror
- Class IV Felony punishable by 5 years in prison and/or \$10,000 fine
- "Rebecca's Laws" across U.S.

FREMONT, Neb. -- On Wednesday morning, at approximately 7:40 a.m. the Fremont Police School Resource Officer was contacted by Administration of the Fremont High School in reference to a posting by a student ♂ on Snapchat that indicated a possible threat against the school involved what appeared to be a firearm.

Snapchat is a video messaging <u>application</u> ☑. Using the application, users can take photos, record videos, add text and drawings and send them to a controlled list of recipients.



The 17-year-old juvenile male suspected of posting the information was not in <u>school</u> ✓ and was contacted by police at his home in Fremont.

The firearm, later determined to be an airsoft gun, was located at another residence and collected as

#### **Neligh-Oakdale Student Arrested For 'Columbine' Threat**

A Neligh-Oakdale student was arrested Monday after allegedly using Snapchat to threaten "to make Columbine look like a (expletive) joke."

According to Ofc. Kraig Nelson of the Neligh Police Department, the threat showed a picture of a toy gun and a message that stated "I'm going to make Columbine look like a 'expletive' joke." This Snapchat message was sent to a large group of students and friends of the suspect.

The Neligh Police, along with the Antelope County Sheriff's Department, received the report of the potential threat from the Neligh-Oakdale School administration.

Nelson said upon investigating the threat, a male juvenile was arrested by the Neligh Police Department for Terroristic Threats, a Class IIIA Felony. The male juvenile was taken to the Juvenile Detention Center in Madison to be held on his charges.

#### **Bullying Definitions**

- •CDC's uniform definition (as of 2015):
  - "Bullying is any unwanted aggressive behavior(s) by another youth or group of youths who are not siblings or current dating partners that involves an observed or perceived power imbalance and is repeated multiple times or his highly likely to be repeated"
  - "behaviors could be verbal, physical or relational"

# School Consequences for Cyberbullying

- Neb. Rev. Stat. 79-2,137
- Definition: "ongoing pattern of physical, verbal or electronic abuse"
- Consequences:
  - Loss of extracurricular privileges
  - Detentions
  - Loss of recess
  - Suspension
  - Expulsion
  - Alternative School Assignment

#### A.N. v. Upper Perkiomen Sch. Dist., 2017 U.S. Dist. LEXIS 2017 (E.D. Pa. 01/10/17)

- Student made "mashup video" and posted to Instagram
  - Combination of "Evan" and "Pumped Up Kicks"
  - "See you next year, if you're alive"
  - "See you next year. It is not a threat, you n\*\*\*s need to chill"
- Students, parents become concerned
- •PA state police contact principal at 2 a.m.
- School cancelled for the following day

#### A.N. v. Upper Perkiomen Sch. Dist., 2017 U.S. Dist. LEXIS 2017 (E.D. Pa. 01/10/17)

- Student not criminally charged
- School sought to expel
- Parents sued
  - No prior discipline history
  - Not special ed or 504
  - Claimed free speech violation
- Court
  - Speech caused material and substantial disruption
  - Speech reasonably led to forecast of disruption

#### A.N. v. Upper Perkiomen Sch. Dist., 2017 U.S. Dist. LEXIS 2017 (E.D. Pa. 01/10/17)

#### Court

 "Although the student argued that the post was meant to be a joke, the student's subjective intent was not relevant to the court's application of Tinker. The Tinker standard also did not require the court to decide whether school officials' characterization of the student's speech as a threat was proper."

  - Charged with second-degree felony for "written threats to kill."
  - When asked why he did it?

- ■16-year-old girl met 17-year-old guy on Kik
- Talked, became friends
- Asked her for pictures
- She said OK








Last week, a 12 year-old Madison, Wisconsin girl received disturbing photos, leaving her upset and embarrassed, and her parents feeling helpless.





- 400+ photographs of "over 100 kids"
- Used "vault" apps to accrue pictures and points
- "the pimp of pictures" had the most points
- Football players at center of scandal cancelled last game of the year
- Prosecutors settled for diversion

Gov. Pete Ricketts has urged state Sen. Bill Kintner of Papillion to resign if allegations are proven true that Kintner exchanged sexually explicit video of himself using his state computer.

A source familiar with the situation said Kintner told investigators about the video when he asked the Nebraska State Patrol for help with computer problems in July 2015.



### Limit electronics?

- Common Suggestions
  - Don't charge the phone or tablet in the bedroom
  - Place computers in public parts of the house
  - Technology Timeouts: Limit texting during meals, homework time, etc.
- •Alternative: track "connected" time and compare to "unconnected" time

# If things may be bad already:

- •Talk to other affected parents, but don't be accusatory
- #1 Complaint from Administrators across the country: "Parents won't do their own dirty work."
- School admins <u>must</u> call the cops/HHS

# If things may be bad already:

- ■mSpy (\$70/mo or \$199.99/yr)
  - Snapchat: "this is the nuclear option"
- ■WebWatcher (\$99.95)
- K9 Web Protection (free)
- App locking, mirroring, syncing
- Block download capabilities
- Internet/Device/Service provider tools
- Turn off "incognito windows"
- Disable in-app browsers

# Taking back the conversation

- Ask kids why they use SnapChat, Instagram, and Saraha,
- Kids use these apps because they are a parentless universe...use them!
- DC is more than monitoring—its about shaping values/lessons to life online
- Talk to them: your kids want to talk!
- > 50% of kids are "open to talking"
